Industry Leader's Speak

Engaging with the Millennial Workforce

Millennials are the largest segment of the workforce in the industries today. They are at cusp of taking up leadership roles in most organizations.

We come across conflicting views regarding whether or not millennials are different from other generations. Some think millennials are similar to other generations but are simply at a different stage of life, while others think that they are fundamentally different. In reality, both point of views have some elements of truth.

In some respect, Millennials are very similar to other generations. At the same time, it's commonly believed that compared to other generations millennial employees are digital natives, expect a faster career growth, have a low attention span and demand much more flexibility in the way they operate. It could be due to difference in the life experiences and up-bringing of Millennials as compared to employees of other generations. However, these traits/characteristics cannot be generalized for all millennials and one always needs to be sensitive of the fact that 'one size does not fit all'.

Therefore, the organizational approach to engage with millennials should be personalized as per individual need and aspirations. Some of the ways that could be adopted, based on the organization context and employee need are as follows:

1) Inclusive Culture and Ongoing Communication

Organizations should focus on building an inclusive and collaborative culture, which fosters risk taking as it tends to strengthen the resolve of the millennial workforce towards the organization's purpose. Trust and values are vital in engaging the millennial workforce.

2) Leadership Style

Leaders should shift from the conventional and directive leadership style to a more collaborative and participative leadership style to effectively engage with the millennials. At the same time it needs to be kept in mind that different strokes work for different people.



3) Charting Growth Based Career Paths

Changes are now happening much more rapidly than ever, and millennial employees are being affected by these changes more strongly than their elders. Hence companies need to effectively and dynamically manage career paths to ensure millennial employees stay engaged. Employers should focus on growth-based careers, by designing careers around experiences rather than positions and motivating millennials through employability rather than title progression.

The key is to keep the employee growing and engaged, through new experiences, not stagnating as they wait for positions to become available. Switching from traditional, position-based careers to growth-based careers helps companies achieve this positive impact.

4) Customized Benefits/Reward

The right rewards could effectively drive satisfaction, and hence engagement. To boost millennial engagement, organizations should identify millennials' most critical needs and ensure their rewards packages address those needs.

5) Flexibility at work

Organizations should provide an employee experience and work environment that provides the employees flexibility and autonomy at work.

6) Engage and Develop Millennials through Technology

Organizations should leverage technology, social media and collaboration tools to engage with millennials across the organization. Millennials prefer to learn and develop through digital and personalized channels. To engage the millennial workforce, organizations need to focus on providing training that fits their preference via personalized developmental channels such as peer-generated content, experiential learnings etc.

In nutshell, as organizations are working to improve the performance, productivity and retention of millennials, slowly the organizational focus needs to shift from just working on the millennials to driving a cultural change, defining the value ethos of the organization and working with multi-generational leaders/employees to create an inclusive work environment.




Gandhi Jayanti Celebrations
