Each Party bears all the charges of its own related activities under this MoU, if not specified differently in further agreements.

This MoU shall be governed by and construed in accordance with the laws of both the United Arab Emirates and India.

The Parties tend to solve all the issues to the implementation of this MoU by means of consultations.

Any amendments, alterations or additions to this MoU must be made in writing as an addendum to this MoU and signed by the duly authorized representatives of the Parties.

This **MoU is to be valid for a length of five (5) years**. MoU shall be subject to review by both parties by the end of its last month and may be extended, amended or terminated at that renegotiation.
